OVERVIEW OF RELATED EXPERTISE

NIOST has provided research, evaluation, technical assistance, consultation, and specialized training on afterschool programs throughout the United States for more than 30 years. Ms. Gannett ensures that research bridges the fields of child care, education, and youth development in order to promote programming that addresses the development of the whole child. Her work ranges from system building for afterschool and youth development to professional development to creating evaluation systems. She directs a national team of 20 Education and Training Associates who travel across the country to lead workshops for out-of-school practitioners and directors. Ms. Gannett has conducted hundreds of seminars and advised policy makers and practitioners throughout the country and internationally.

Project Director of the Outcomes Evaluation Project. Funded by the Massachusetts Department of Education After School and Out-of-School Time (ASOST) Program and the 21st Century Community Learning Center (21st CCLC) grant programs, includes the development of Survey Development Tools for Teachers and Staff (SAYO-T and SAYO-S) and APT Program Observation Tool and Questionnaire. The network brought together individuals and organizations dedicated to developing a strong, diverse after-school and youth development workforce that is stable, prepared, supported and committed to the well-being and empowerment of children and youth. The five key areas of the project: standards and competencies; professional development and training resources; learning delivery systems; career ladders and compensation guidelines; and research and evaluation systems.

Project Director of the Career Pathways project, funded by Cornerstone for Kids and Packard Foundation. NIOST partnered with the Forum for Youth Investment and Child Care Services Association to develop a set of guidelines to promote and strengthen the youth work workforce, with the aim of increasing stability, preparation, support and commitment to the well-being and empowerment of youth. The main objectives of the project revolved around increasing the education, compensation, retention, and development systems within the youth work field. With a few main pilot states, including Pennsylvania, Minnesota, and Missouri, NIOST and its partners took concrete steps to analyze systems, provide scholarships, create fund development plans, and develop a team of mentors that engaged stakeholders and create buy-in for the project.
