# Research Conducted by and for Student Parents





#### Collaborative Action Research

- Intuitive research process beginning in direct response to a community need.
- Research process driven from beginning through dissemination by input and collaboration with student parents as project leaders and researchers.
- Researchers solicits and responds to community feedback
- Flexible and adaptive working practices leveraging technology allow national collaboration and student-parent friendly employment in their field of study
- Research is designed and implemented with intent of social impact/change.





# National Family Housing Database

294 colleges or universities in the United States have family housing (10%)

Region 1 (New England) - 21 (9%)

Region 2 (Mid Atlantic) - 19 (4%)


Region 3 (South)-72 (9%)

Region 4 East (Great Lakes) - 69 (10%)

Region 4 West (Plains/Rockies) - 65 (20%)

Region 5 (Pacific Northwest) - 33 (21%)

Region 6 (West) - 15 (5%)

# New England


Of the 229 accredited colleges and universities in New England:

- 21 offer Family Housing (9%)
- 69 have a Campus Childcare Center (30%)
- 37 offer specific scholarships for student parents (16%)
- 34 have a women's resource center (15%)
- 16 have a work/life center (7%)
- 16 have a student parent center or program (7%)

17.8% of New England Undergraduate Students are parents.

This reflects a 20.8% increase in this population between 2004-2012.


#### The Mid-Atlantic

Of the 539 accredited colleges and universities in the Mid-Atlantic:

- 19 offer Family Housing (4%)
- 152 have a Campus Childcare Center (29%
- 37 offer specific scholarships for student parents (7%)
- 69 have a women's resource center (13%)
- 3 have a student parent center or program (1%)

19.6% of undergraduates in the Mid-Atlantic are parents.\*\*

This reflects an 18.2% increase from 2004-2012.\*\*

# Preliminary Data from the South

	<u>Florida</u>	<u>Texas</u>
Family Housing	7 (9%)	34 (21%)
Childcare	30 (39%)	37 (23%)
Scholarships	18 (23%)	17 (10%)
Women's Center	3 (4%)	10 (6%)
Student Parent Program	1 (1%)	5 (3%)



Wellesley

Student parents represent 27% of undergraduates in the Southeast (Florida) and 34% of undergraduates in the Southwest (Texas). State-level data is not available.\*\*



### Limitations & Restrictions

- The existence of programs does not ensure student access:
  - Affordability
  - o Capacity
  - o Access
  - Many programs target faculty/staff retention over student retention
- Women's centers and Work/Life Centers
- Added additional services to protocol (e.g. food pantries, clothing banks, emergency loans, etc.)
- Programs are being eliminated or transitioned to other models (e.g. off-campus partnerships).
- Full dataset is still incomplete but will be the first comprehensive national dataset on student parent programs.
